WHAT IS USP 800?

The purpose of USP <800> is to protect personnel and the environment. This would include receipt, storage, mixing, preparing, compounding, dispensing, administering, and disposing of hazardous drugs. These guidelines require a comprehensive approach to avert worker and environmental exposure to HD's. This includes having a compounding supervisor, a designated individual who develops, enforces proper procedures and supervises facility compliance with this chapter and other applicable regulations. They are also responsible for ensuring the competency of other personnel and making sure appropriate PPE is donned during HD handling. Standards apply to all personnel who compound HDs preparations and all places where HDs are prepared, stored, transported, and administered. Our USP <800> line of products was developed with you in mind, because your safety and the safety of your employees matters.

PERSONAL PROTECTIVE EQUIPMENT

SECTION 7.0 <USP 800>

“Personal Protective Equipment (PPE) provides worker protection to reduce exposure to HD aerosols and residues. When performing a task in situations where C-PECs are not generally available, such as treating a patient or cleaning a spill, additional PPE may be required. The NIOSH list of antineoplastic and other HDs provides some general guidance on PPE for possible scenarios that may be encountered in healthcare settings.

Gloves, gowns, head, hair, and shoe covers are required for compounding sterile and nonsterile HDs. Gloves are required for administering antineoplastic HDs. Gowns are required when administering injectable antineoplastic HDs. For all other activities, the entity’s SOP must describe the appropriate PPE to be worn based on its occupational safety plan and assessment of risk (if used). The entity must develop SOPs for PPE based on the risk of exposure (see Types of Exposure) and activities performed. ”

Appropriate PPE must be worn when handling HDs including during:

- Receipt
- Storage
- Transport
- Compounding
(sterile and non-sterile)
- Administration
- Deactivation/Decontamination
- Cleaning and Disinfecting
- Spill Control



GLOVES SECTION 7.1 <USP 800>

“When required, chemotherapy gloves must be tested to American Society for Testing and Materials (ASTM) standard D6978-05 (2019) (or its successor). Chemotherapy gloves must be powder-free because powder can contaminate the work area and can adsorb and retain HDs. Gloves must be inspected for physical defects before use. Do not use gloves with pin holes or weak spots. Chemotherapy gloves must be changed every 30 min or when torn, punctured, or contaminated.”

SPILL CONTROL AND CLEANUP

SECTION 16.0 <USP 800>

“The entity must establish SOPs for the labeling, handling, packaging and transport of HDs. The SOPs must address prevention of accidental exposures or spills, personnel training on response to exposure and use of a spill kit. Examples of special exposure reducing strategies include small-bore connectors (such as Luer Lock) and syringes, syringe caps, CSTDs, the capping of container ports, sealed impervious plastic bags, impact-resistant and/or water-tight containers and cautionary labeling.”

Cleaning	Remove organic and inorganic material	Germicidal detergent and sterile water

CRITICAL AREAS

CLEANING STEP	PURPOSE
Pharma-Hol [®]	To be used at the beginning and end of each shift, every 30 minutes (when constantly compounding), in between batches, after any known or suspected spills.
Pharma-D [™]	A STERILE Quaternary Ammonium disinfectant to be used as an additional disinfectant added to your rotation at the beginning and end of each shift, followed by Pharma-Hol.
Pharma-Surface Guard [®]	Chemo neutralizing wipe (ISO 5) that should be used if there is an known or suspected spill/contamination of any HD's. Can be added into the rotation in between batches to prevent cross contamination.
Decon-Spore [®]	A STERILE H2O2 + Paracetic Acid sporicidal disinfectant that is to be used once a month or weekly *depending on what category CSP's are being compounded*, during your deep cleaning to prevent/kill any potential spores.

SPILL CONTROL AND CLEANUP

ACUTE CARE DISINFECTANT GUIDE CONT.

NON-CRITICAL AREAS

Refer to chart attached for additional information/guidelines. It is best practice to rotate cleaners and disinfectants during this process.

Horizontal surfaces (floors, counter tops, easily cleanable surfaces) - Clean daily with Pharma-Hol and/or Pharma-Sat Mop Covers, rotating with Pharma-D.

Vertical surfaces - Clean walls, ceilings, storage areas monthly with Pharma-Hol and/or Pharma-Sat Mop Covers, rotating with Pharma-D.

If a pharmacy is compounding Category 3 CSPs, they are required to 'deep clean' once a week. We recommend picking one day a week to add a sporicidal into rotational cleaning procedures to stay ahead of contaminants. For pharmacies compounding Category 1 & 2 CSPs, the 'deep clean' is needed monthly. We recommend tracking which days a sporicidal is added by choosing a specific day of the week/month and documenting it. For example, choosing every Sunday/week or every first Sunday/month would help keeping track of your cleaning regime. These are only suggestions and are in no way supposed to replace your current SOP and P&P's.

GOWNS SECTION 7.2 <USP 800>

"When required, disposable gowns must be tested and shown to resist permeability by HDs. Gowns must be selected based on the HDs handled. Disposable gowns made of polyethylene-coated polypropylene or other laminate materials offer better protection than those made of uncoated materials. Gowns must close in the back (i.e., no open front), be long sleeved, and have closed cuffs that are elastic or knit. Gowns must not have seams or closures that could allow HDs to pass through."

Cloth laboratory coats, surgical scrubs, isolation gowns, or other absorbent materials are not appropriate outerwear when handling HDs because they permit the permeation of HDs and can hold spilled drugs against the skin, thereby increasing exposure. Clothing may also retain HD residue from contact, and may transfer to other healthcare workers or various surfaces. Washing of non-disposable clothing contaminated with HD residue may transfer drug residue to other clothing.

Gowns must be changed per the manufacturer's information for permeation of the gown. If no permeation information is available for the gowns used, change them every 2–3 hours or immediately after a spill or splash. Gowns worn in HD handling areas must not be worn to other areas in order avoid spreading HD contamination and exposing other healthcare workers."

"Head and hair covers (including beard and moustache, if applicable) and shoe covers provide protection from contact with HD residue on surfaces and floors. When compounding sterile HDs, a second pair of shoe covers must be donned before entering the buffer room and removed when exiting the buffer room. Shoe covers worn in HD handling areas must not be worn to other areas to avoid spreading HD contamination and exposing other healthcare workers.

Disposable sleeve covers constructed of coated materials may be used to protect areas of the arm that may come in contact with HDs. If used, sleeve covers must be carefully removed and properly disposed of after the task is completed."

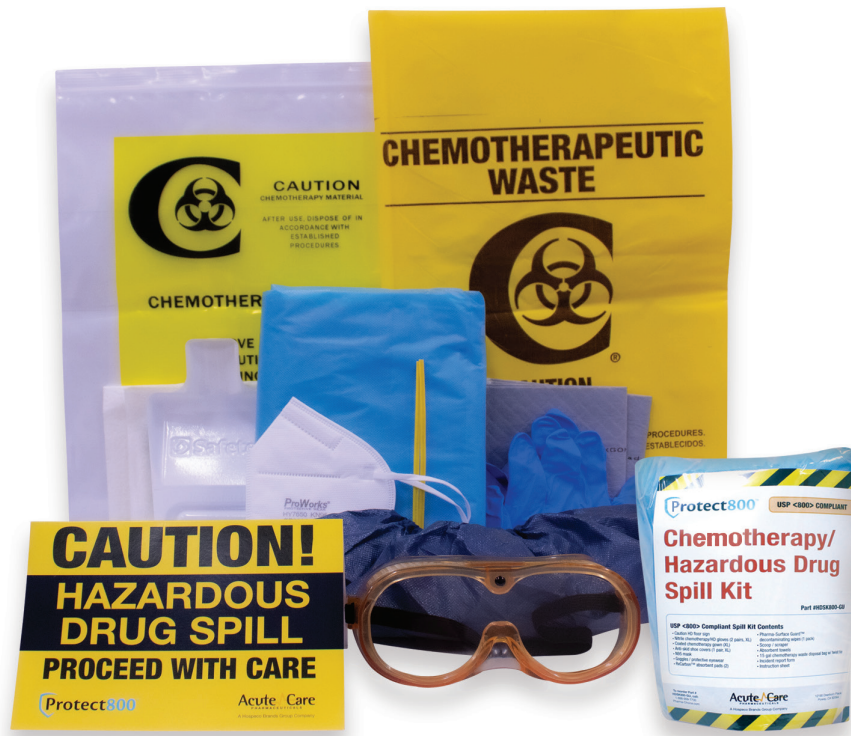

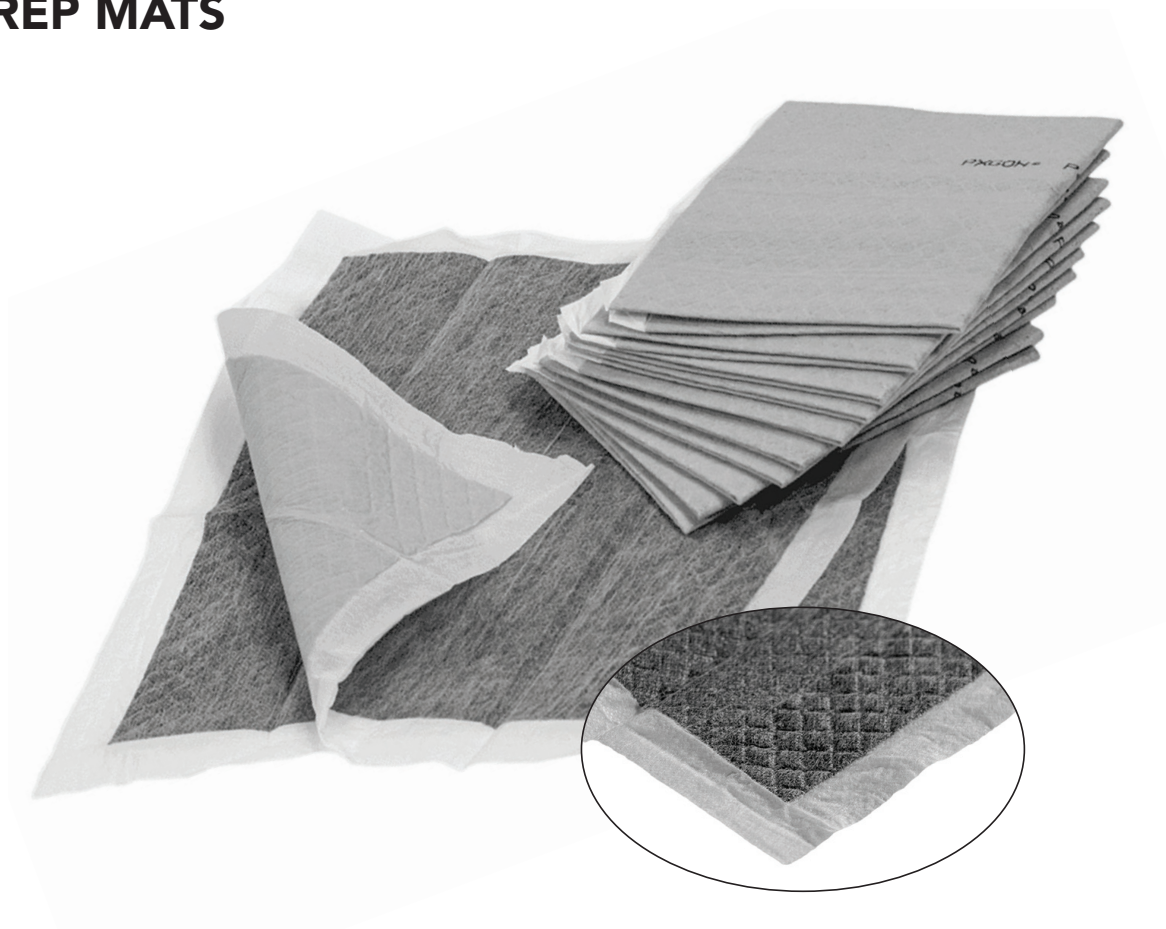
